Respecting The Joint Funding Of Certain Recreation Facilities.

The Council of the Village of Wilcox, in the  
Province of Saskatchewan, enacts as follows,


1. The Village of Wilcox is hereby authorized to enter  
into an agreement, attached hereto and forming a part of  
this bylaw, and identified as Exhibit A, with the following  
municipalities:

Wilcox are hereby authorized to sign and execute the



Memorandum of Agreement made this 14th day of December,  
1981 A.D.

Between: The R.M. of Bratt's Lake No. 129

and

The Village of Wilcox

This Agreement Witnesseth As Follows:

1. The parties to this agreement agree to provide financial contributions in the amounts further provided in this agreement towards the costs of operating the recreational facilities mentioned in this agreement.

2. The parties to this agreement agree that the amounts referred to in 1. above shall be as follows:

Annual grants for operating purposes may be provided to each of the following groups:

- Wilcox Senior Hockey Team
- Wilcox Senior Baseball Team
- Globe Theatre Presentations
- Playground Facilities Expenditures
- Wilcox Minor Sports
- Wilcox Community Rink
- Wilcox Community Curling Club
- Wilcox Figure Skating Club
- Community College Classes

And all other groups or organizations whose request for assistance has been approved by the Wilcox and District Parks and Recreation Authority in any particular year.

The operation of all recreation facilities and the grants provided for operating purposes shall be administered and regulated from year to year by the Wilcox and District Parks and Recreation Authority and the total grants to any individual organization may vary from year to year depending on the necessity and availability of such grants.

3. The Parties to this agreement agree that the amounts payable by the Village of Wilcox shall be paid to the Wilcox and District Parks and Recreation Authority on or before the first day of May in each year.

4. The Wilcox and District Parks and Recreation Authority hereby agrees to provide the Village of Wilcox such documentation and accounting necessary under the Inter-Municipal Recreation Program to substantiate the amount of monies expended upon the recreational facilities mentioned within this agreement, such documentation to be provided on or before January 31 in the year following the expenditure of such funds.

5. The Village of Wilcox and the R.M. of Bratt's Lake No. 129 agree that the recreational facilities mentioned in this agreement and supported by the amounts also mentioned in this agreement will be available for all residents of each municipality on an equal opportunity basis.


6. It is understood and agreed that this agreement shall be continuous but the agreement may be terminated by either party to the agreement giving thirty days notice in writing.


